

Jay Z Concert Tickets Contest Rules

Official Rules

1. **TO ENTER: NO PURCHASE NECESSARY.** Entrants must be 16 years of age or older and a legal resident of Maryland, Virginia or Washington DC. Sweepstakes begins on Monday, January 18, 2010 at 9AM EST and ends on Sunday February 14, 2010 at 11:59PM EST. To enter, log on to DC50tv.com, click on either the CONTEST link or the Jay Z Contest Link and complete the official entry form, submitting your name, age, address, telephone number, and email address. Entrants must use their own name and current residential address. Entries containing technical or electronic reproductions, e-mail entries containing attached files are not eligible and will be rejected. Sponsors are not responsible for lost, incomplete, damaged, illegible, late, or misdirected entries, or for errors in mechanical transmission, technical difficulties or inability to transmit Internet entries.

2. **ENTRY DEADLINE: All entries must be received by 11:59 PM EST on Sunday, February 14, 2010.**

3. **SELECTION OF WINNERS:** On Monday February 15, 2010, two (2) entries will be selected at random from all entries and will be declared the winners, subject to eligibility verification and compliance with these rules. The winner will be notified by e-mail or phone provided in the entry submission. A Winner who is determined to be ineligible, cannot be reached by reasonable means within a reasonable amount of time after the drawing, or who otherwise fails to comply with these Official Rules shall be disqualified, and another entry will be selected at random from the remaining eligible entries until an eligible winner is selected.
